2. You are required to have a permit prior to the use of fireworks in the Town of Little Falls.
3. Special Conditions:
  - a. To protect the public health and safety, a permit may be denied or cancelled during periods of high fire danger.
  - b. A copy of this permit shall be sent to the Monroe County Sheriff's Department, the Wisconsin DNR and the Cataract Volunteer Fire Department, at least 2 days prior to the date of authorized use of the listed fireworks.
  - c. A permit shall not be issued to a minor under age 18.
  - d. The Town and its officials and employees shall not be civilly liable for damage to any person or property caused by fireworks for the sole reason the Town issued a permit in accordance with the requirements of § 167.10(3), Wis. Stats.
  - e. The permittee is responsible for compliance with the fireworks law, §167.10, Wis. Stats.
